**Title:** Agreement with Stratford Power and Sail Squardron/Tillsonburg Power and Sail Squadron and Stratford Tourism Alliance for the operation of the H.M. S. Razzamajazz

**Objective:** To consider entering into an agreement with the Stratford Power and Sail Squadron/Tillsonburg Power and Sail Squadron (SPSS/TPSS) and Stratford Tourism Alliance (STA) for the maintenance and operation of H.M.S. Razzamajazz.

**Background:** The H.M.S. Razzamajazz is a barge owned by the City of Stratford that cruises along the Avon River providing musical entertainment for visitors and residents of Stratford. In 2009, the City entered into an agreement with the Stratford Lions Club to operate and maintain the barge as the STA was no longer interested in the operation of the barge. Stratford Tourism Alliance inherited the funding of the operation when the Alliance was established, as prior to that time, the operation was funded by the City through Tourism Stratford.

In 2016, the City was informed that the Stratford Lions Club was no longer interested in operating and maintaining the barge. Discussions were held between the City and STA to discuss the ongoing operation and maintenance of the barge. STA in turn had discussions with the SPSS. As a result, STA and SPSS agreed to enter into an agreement with the City for the continued operation of the barge. The agreement was for a one year period with an option to renew for an additional one year term. The agreement was renewed in 2017 and has now expired.

**Analysis:** The SPSS operates the Razzamajazz program by providing volunteers to operate the barge and managing the music program during the summer months including scheduling the performances.

The SPSS is now working with the TPSS in order to maintain their operations and wish to enter into another agreement with STA and the City to continue to operate the barge.

The agreement is the same as previous agreement with the exception that the City has the option to renew the agreement for five additional one year terms upon receipt of a written request for an extension by the SPSS/TPSS and the STA.

**Financial Impact:** The STA provides \$2,500 a year to the SPSS for operation and minor maintenance. The City is responsible for major repairs to the barge as they are required and would budget accordingly.

In 2016, a grant was provided to SPSS in the amount of \$481.38 and in 2017 a grant was provided in the amount of \$617.31. Both grants were to assist SPSS with additional minor repair items.

Staff Recommendation: THAT The Corporation of the City of Stratford enter into an agreement with the Stratford Tourism Alliance and Stratford Power and Sail Squadron/Tillsonburg Power and Sail Squadron for the operation of H.M.S. Razzamajazz for a one year renewable term.
