**Title:** 2017 Grant Request – Stratford Power and Sail Squadron

**Objective:** To consider a grant request from Stratford Power and Sail Squadron

**Background:** The Razzamajazz barge is owned by the City. The Stratford Power and Sail Squadron operate the Razzamajazz program with services such as providing volunteers to operate the barge and managing the music program during the summer months including scheduling the performances.

**Analysis:** The Stratford Power and Sail Squadron's agreement with Stratford Tourism Alliance and the City of Stratford for the Razzamajazz was renewed for an additional one year term in 2017. As per the agreement, Stratford Tourism Alliance provided the group with \$2,500 for minor maintenance and entertainment fees. The group advises that these funds have been depleted and they have encountered additional minor repair items in the amount of \$617.31 including HST and they are therefore, requesting a grant from the City to offset these costs.

In 2016, the Stratford Power and Sail Squadron received a grant for \$481.38 including HST for repairs to the barge.

**Financial Impact:** There are funds available in the 2017 grants contingency to cover these costs.

Staff Recommendation: THAT the 2017 grant request from the Stratford Power and Sail Squadron be considered by Sub-committee.
